Good News Stories contd

We are delighted to announce that the DfE have approved the conversion of Acle St Edmund CE Primary School and Little Plumstead CE Primary School to join St Benet's MAT on 1 Sept 2023.

Prior to this, Norfolk County Council approached Acle's LGB to ask them to provide leadership support to Little Plumstead through an interim Executive Headteacher arrangement, commencing on 1 June. This



means that Acle's Headteacher, Rebecca Clarke, will be overseeing both schools from this date with support from Rachael Holmes as Head of School at Little Plumstead.

St Benet's Central Team have been supporting both schools through the DfE's Trust School Improvement Offer and will continue to work closely with them in the run-up to their conversion in the autumn.

Safeguarding

We are delighted to introduce our new permanent **Head of Safeguarding, Louise Veeren**. Louise is employed by DoNESC but reports in to the two Diocesan MAT CEOs, Richard Cranmer and Oliver Burwood. We've asked Louise to introduce herself to St Benet's staff:

I would like to introduce myself as the new Head of Safeguarding and I am very much looking forward to working with you and supporting you. I will be a regular feature in B-Comms, providing information to help keep safeguarding at the forefront of everyone's mind.

I trained as a teacher in 2005 and followed this by teaching dance and performing arts in two schools in south London. My second school was an all through academy for ages 3-16, therefore I was able to have the experience of teaching across key stages 1-4. Whilst at Globe Academy I developed a passion for pastoral care and became Head of Year and then Assistant Headteacher.

I moved back to Norwich in 2012 to take up a post at Thorpe St Andrew School and Sixth Form where I have been for the past eleven years. I worked as Senior Designated Safeguarding Lead at TSAS, leading a team of 12 DSL's whilst also continuing to teach performing arts and PSHE. I absolutely loved this role and feel passionate about developing a culture where children are and feel safe.

I am now really excited to continue this work across St Benet's. I look forward to working with you on the safeguarding audits and compliance work. In the new academic year, I will be setting up DSL Networks to give us an opportunity to work together and share best practice across the Trust.

Safeguarding Update from Louise



Online Safety

This week I would like to draw your attention to the site 'Omegle'.

Omegle is a website that pairs random strangers for live text or video chats. It's slogan is 'talk to strangers'. Omegle markets itself as a great way to meet new friends, however it has been known to feature pornography and inappropriate content within chats so it is important that parents are aware of the risks associated with the site. There is an option for an adult (18+) content and a section for people aged 13+ with parental consent.

Prevent

Prevent is covered within the safeguarding policy and also within your whole school annual training. However, there is also further online training which is particularly useful at DSL level.

There are three courses, the first one aimed at everyone. It wouldn't be necessary to send this out to all staff as the content is covered in the annual training unless you feel there is a particular need in your school. However, the second and third courses aimed at DSL's are very useful as a reminder of how and when to refer to Prevent and information around Channel. If as DSL you do complete this, unfortunately you have to complete part one to get to two and three. At the end there are downloadable certificates you can use as evidence of additional training. It takes between 30-60 minutes to complete each training.

Increase in Scabies Cases

We have been made aware that cases of Scabies are on the rise in Norfolk, especially in schools. Although this is not on the same scale as Covid or Strep-A we feel it is appropriate to share guidance with our academies via the links below. As always, our stance should be to follow NHS and CDC Guidance.

Any confirmed cases should not return to their school for at least 24 hours after the first treatment.

Governance

Message from Hannah Monk, Head of Governance, DoNESC: Thank you to the school office teams who have contacted me about the charges for Governor DBS checks. I understand that there is a new charge of a £14 administration fee for Governor DBS checks through the new intermediary service. I have double-checked on the charge with the new provider and there is no was around it at the moment, but I will keep advocating on your behalf. In the meantime, please double check that only the volunteer rate of £14 is applied to your governor's DBS checks.

For the rest of this school year the cost will need to go to the academies but from September, I will take it into my section of the Trust's costs for all appointment and reappointment DBS checks for governors. From September, please process the DBS as usual and then send the invoice to the governance team to arrange payment. Don't worry if your invoice groups together staff and governors, we can separate the governance costs out at this end while you carry on with the staff costs at your end.

Governance Diversity Information

Last week the DfE added the publication of diversity data for "trust boards... and any local committees" to the information that Academies, Free Schools and Colleges should publish online. The Confederation of School Trusts (CST) has responded with legal advice regarding avoiding the identification of individuals.

We have this data collated for St Benet's MAT and we have been able to publish the following statements on the Trust website to comply with the new requirement. This means that the Trust and all the schools are now compliant and there is no further action needed.

Age

31 – 45 : 45 % 46 – 60 : 29% 61 and over : 16%

Gender

Female: 56% Male: 43% **Religion or Belief**

Christian: 58% Other faiths: 6%

No religion or belief: 19.5% Prefer not to say: 17%

We also collect data on ethnicity, disability and sexual orientation but have chosen not to publish data in these areas at present.

Thank you to all governors and trustees who provided this information at the point of application; your openness has enabled St Benet's MAT to respond to this requirement very quickly.



Health Shield

The portal (Members' Area) that employees use to access their health cash plan will look a bit different from Tuesday 25 April.



What they need to do:

When employees first login, they'll need to reregister using their member number (this can usually be found on any correspondence from Health Shield) and their date of birth.

Once they've re-registered, they can login and use the new look portal. From here they have the option to download Breeze, the digital health app, and have access to wellbeing services on the go.

What does this mean for employees?

- Easier access to their Cash Plan benefits via the Breeze app
- Ability to submit a claim via Breeze

Strike Days

Please remember to call the Duty Line if you have any urgent HR queries on strike days.

SAMpeople

We have listened to feedback and can confirm that we are no longer proceeding with SAMpeople as a separate HR system. Instead, we will be using the Orovia HR modules. This means in one system you will have all your payroll and HR needs.

We are planning a gradual and phased roll out of the HR modules, supported by full training. We will be in contact regarding this in the future.

Apprenticeships

We have also listened to you all regarding Apprenticeships. In an effort to ensure all academies can access the apprenticeships, please note the following change.

Academies now have the option of either:

Offering the Government agreed Apprenticeship hourly rate of £5.28 or offering The National Living Wage/age related National Minimum Wage:

- National Living Wage for over-23s: £10.42 an hour
- National Minimum Wage for those aged 21-22: £10.18
- National Minimum Wage for 18 to 20-year-olds: £7.49
- National Minimum Wage for under-18s: £5.28

Therefore, you can now offer the Government Apprenticeship rate of £5.28, or an enhanced rate.
