### **Good News Stories**

Harleston Sancroft Academy have been working with Future Action, an organisation who aim to transform young people's mental wellbeing through whole school early intervention teacher training courses. They work with over 60 schools in Norfolk in partnership with Norfolk County Council.

Future Action have recently issued a blog on their website here about their work with Sancroft. Here's an extract:



Tutors deliver fortnightly activities on a Monday afternoon covering a range of early intervention wellbeing topics such as mental fitness, healthy habits and accessing the happiness chemicals. Molly Harris spearheaded the programme by completing our online training, setting the vision for the Academy and adapting the RISE Up resources to meet the needs of Sancroft students for her team of form tutors.



Lewis Disbury is a PE Teacher and form tutor who delivers the RISE Up activities to his vertical tutoring group. Lewis said, "I really enjoy delivering the activities with my form. It is a great opportunity to discuss all things wellbeing with my tutees, it has prompted some brilliant conversations and it helps me show the young people in my form that I care about them."

"Our young people particularly benefitted from understanding the link between physical activity and mental wellbeing, and how different activities help our young people manage their mental wellbeing. Our school is really proactive about our children's mental health."



"We are now about to add the RISE Up programme to some of our PE lessons as well to incorporate physical activity to boost our children's wellbeing, and to ensure PE is meaningful for all our young people."

The RISE Up programme is part of a range of methods the Academy uses to ensure the mental wellbeing of their young people. The Academy has a group of Student Mental Health Leaders in the Secondary Phase who raise awareness about mental wellbeing, fundraise, and present in assemblies

## **Safeguarding Update-1**

#### Safeguarding

- Never think you have done enough in creating a safer culture
- Always believe it could happen here
- Keep safeguarding high on everyone's agenda
- Never rely on one process to keep children safe

#### The Single Central Record

The Single Central Record is one of the queries I am asked about most. The SCR supports the process of Safer Recruitment and is one of the processes followed to ensure that children are protected from those who wish to cause them harm.

The DfE has produced an excellent recorded webinar on the Single Central Record which provides answers to the concerns and questions that you and the staff completing the SCR may have. It serves as a refresher to supplement the initial training.

#### **DSL Training**

Is all your DSL training up-to-date? You must keep DSL training within two years with additional training in between.

The Norfolk model recommends that you have multi agency training every three years. Often the booking of this needs to be done well in advance due to capacity so ensure that this is being regularly checked. The most interesting and useful multi agency courses book up quickly.

There are other training courses that can be completed to keep training and knowledge up to date.

The Norfolk Safeguarding Team is offering funded (free) training on the Norfolk Graded Care Profile for Designated Safeguarding Leads. You do not need to keep any old/out of date training records. For example, only keep your most recent DSL/refresher training - you do not need to keep all your training and updates if you have been a DSL for a long time.

#### **DSL Meetings**

Are you holding regular DSL meetings? Weekly is best or no longer than fortnightly. This is one important tool that you have to ensure that you are regularly discussing and reviewing cases. A record of this must be kept.

For schools using Tasc Cura there is a useful report called 'Frequent Concerns'. You can look at the amount of concern over a period of time, for example anyone who has three concerns logged in seven days. It enables you to change the amount of concern over the amount of days to suit your school. It is useful to show lower level concerns over a period of time that may flag up to you a bigger concern to help ensure that nothing is missed.

#### Neglect- what the data tells us:

- · Neglect is the most common form of abuse.
- 1 in 10 children in the UK have been neglected.
- Concerns around neglect have been identified for half of children who are the subject of a child protection plan or on a child protection register in the UK
- Less than 1% of Childline counselling sessions are about neglect, possibly because children often don't recognise their experience as neglectful. Younger children are more likely than older children to be the subject of a child protection plan in England because of neglect, although research suggests that the neglect of older children is more likely to go overlooked.

#### Norfolk Graded Care Profile Training

I would like to draw your attention to the Norfolk Graded Care Profile Training as a tool to assess and work with families where that are concerns around neglect. I completed the training myself this week and it was very worth the time I spent. I will send the resources to anyone who would like to see then but if you could attend a session that would be great. Ideally one DSL to attend and then cascade the information to other DSL's. It is much improved from the previous assessment tool and much easier to use.

The cost of the training is the cost of your time and it is bookable through the Norfolk Training and Events Pages. You will also receive a certificate for your records!

I would be really keen to find out how you are using this as one of your 'tools' to support children and families. Please feel free to feedback via email when you have started using this. It would be great to find out how this is working in practice.

## **Operational Updates from DoNESC**

#### **Trust-wide IT Audits - All Schools**

IT audits will be taking place throughout June (from 6 June) carried out by BCTec Ltd – an independent company who specialise in the education sector. These are commissioned by the Trust/DoNESC to inform our strategic planning and ongoing/wider support of schools and to ensure we are meeting regulations and requirements in terms of our security and setup.

We anticipate these should cause little (or no!) disruption. Further information and school specific dates will be shared directly in due course.

#### **Capita Broadband Contracts**

Capita/NCC have advised schools that the broadband connection for the school will be cancelled next year and to start making alternative arrangements. You do not need to do anything at Academy level.

We are aware of this and it is all already in hand centrally. We will be looking at the most cost effective options for all of the schools across St Benet's and will be keeping you updated as we move forward.
