# **Governance Update**

Governance support both centrally and across all Trust schools is provided by DoNESC's Governance Team, led by Head of Governance Hannah Monk (centre) and with support from Tara Burrows, St Benet's Governance Officer (right) and Dawn Knights, DNEAT Governance Officer and Training Facilitator (left).

## **Pupil Leave of Absence Form**

The Governance Team have recently issued a new Pupil Leave of Absence form for schools to use, which overcomes data sharing issues where parents may be acrimoniously separated. The new form has been developed with input from the Head of Safeguarding and no longer requires parents to include their contact details.

The new form is available under the Standard Forms tab in the St Benet's Resource Hub on the Trust website, which all school offices have login details for: www.stbenets.org/login/. It is called Pupil Leave of Absence Request Form 2023.

## **EHCP Support Guide**

Governance have seen an increase in parents making a Subject Access Request when what they actually need is information to support an EHCP or medical needs assessment.

The Head of Governance has therefore written a guidance note that schools can make available to parents to aid them in making the right choice when requesting information. This is available under the DoNESC Central Information tab in the St Benet's Resource Hub on the Trust website, which all school offices have login details for: <u>www.stbenets.org/login/</u>. It is called EHCP Support Guide for Parents 2023.

## **Freedom of Information Request**

The Benedict Blythe Foundation is contacting schools across the country making a Freedom of Information request for information regarding arrangements for children with allergies. The Head of Governance has done some research and the Benedict Blythe Foundation's purpose is the safety of children with allergies in schools, so it appears they are doing some quite wide-reaching research.

Organisations have 20 working days to respond to Freedom of Information requests. It will be most expedient and appropriate for schools to reply directly to the FOI because the schools hold the data. It is also okay to say that the school does not have the information requested when that is the case.

They are asking about policy, and allergies are covered in the section "Allergens, anaphylaxis and adrenaline auto-injectors (AAIs)" in the Trust's Supporting Pupils with Medical Conditions Policy.

## Safeguarding Training for DSL's

There have been lots of discussions around the costs of multi-agency training for schools and also around the context and availability of training. Whilst multi-agency is positive to attend as it is valuable to have training and discussion with other agencies, it is not in our Trust policy that this has to be completed every three years. This is the Norfolk model and not what we now have in our policy. The Trust policy is that we must be trained every two years (statutory refresher) and the DSL's undertake training that is contextually useful to their role. This can come from a variety of resources that may or may not be the Local Authority. You may wish to use: Home Office PREVENT, NSPCC, CEOP, LGFL, SWGFL.

#### Right to Work on the SCR

Has everyone had their right to work documents checked and copied? This includes governors and volunteers. For British and Irish citizens this is either:

- A British passport
- An Irish passport or passport card

If the person has neither of those it could be:

- A UK birth or adoption certificate
- An Irish birth or adoption certificate
- A certificate of registration or naturalisation as a British citizen

In addition to this they must provide an official letter or document from a previous employer or agency. Please note that a driving licence is not a Right to Work document, this can be used for identification purposes but NOT a Right to Work.

For non-British or Irish citizens, Right to Work can be proved by:

- A share code
- Immigration documents

### **Elective Home Education Guidance Review**

This consultation seeks views on revised versions of the non-statutory elective home education (EHE) guidance for Local Authorities and parents. The EHE guidance was last updated in 2019 and is due for review. Both sets of guidance are a vital resource for parents and Local Authorities to help them understand their roles and legal responsibilities around EHE. The changes made aim to help parents and Las better understand what they are required to do to ensure all children receive a suitable education: <u>Elective Home Education guidance review - Department for</u> <u>Education - Citizen Space</u>
