# congratulations Garboldisham Primary

Garboldisham CE Primary
Academy will be celebrating this
Christmas as it has received a
glowing **Good** Ofsted report,
where four out of five categories
of the inspection received an
'Outstanding' grading.

Previously the primary school was graded as Inadequate, however it has undergone an impressive turnaround since joining St Benet's in 2020.

Subsequently it federated with Dickleburgh CE Primary in September 2021, creating the Beacon Federation, led by Executive Headteacher Moira Croskell.

The school has worked hard, and is delighted with its progress from Inadequate to Good in a very short space of time.

Moira commented: "I am delighted that the inspectors were able to clearly see what a supportive and inclusive learning environment we have developed for our pupils and just how much they thrive at Garboldisham.

'Governing bodies and proprietors should ensure that all governors and trustees receive appropriate safeguarding and child protection (including online) training at induction. This training should equip them with the knowledge to provide strategic challenge to test and assure themselves that the safeguarding policies and procedures in place in schools and colleges are effective and support the delivery of a robust whole school approach to safeguarding.'

#### **Single Central Record**

The Single Central Record must be checked every half term by either the Headteacher or Executive Headteacher in the school. St Benet's Improvement Directors will check annually. Louise Veeren will also check as part of the audit visit. It is really important that there is a record of the check and the actions noted.

It is also very important to ensure that staff who are no longer working at the school are removed from the SCR. The advice on using the new SCR is that an identical SCR is kept for leavers so that they can move onto this.

KCSIE notes this:

272. The details of an individual should be removed from the single central record once they no longer work at the school or college.

The Trust has its own Single Central Record that schools are now adopting. In order to launch this in your school then book a time for your SBM/Admin team to work with Louise Veeren on this in the new year: <a href="mailto:louise.veeren@donesc.org">louise.veeren@donesc.org</a>.

#### **Government Consultation**

Although we know that children can be vulnerable to harm by adults, there is also growing research into children displaying harmful behaviours towards parents/caregivers. There is no agreed definition for this type of harm or abuse, making it difficult to identify and talk about. This consultation seeks views on both the headline terminology for, and descriptors of, CPA which will together make up the definition.
