The page provides an overview of the Trust, its culture and Values, the benefits of working within your academies, and a case study highlighting the CPD opportunities available to employees.



# **Ergo Merger with Office Xpress**

 $\Rightarrow$ 

From 1st January 2025, Ergo Computing will trade as OfficeXpress Europe Ltd.

Your Headteachers have been sent full details of ths merger, along with FAQs and posters to go up in school, but the most important points are:

- Your points of contact and onsite engineers remain the same, as do all processes and procedures. However, contact email addresses (including the Helpdesk email address) are changing.

# **Data Protection Update**

Data Protection by Design and Default - integrating robust privacy practices to ensure that personal data is protected from the outset and throughout its lifecycle.

#### New Year, New Form

I want to share three quick-fire reminders to start the new year:

- 1. Every time you fill in a form with personal details on it, start a new form from blank. I know it can be tedious to have to write the same information several times and it would be so much easier to overtype the last one you did but, when we're dealing with often sensitive information related to children, the risk is too great. Start a fresh form every time.
- 2. *Everyone* working in the Trust who has access to personal data should have completed the data protection training on IAM Compliant by *31 December 2024*. Thank you to everyone who has done so, this is a great step forward If you have not completed it yet, please do so by the end of January at the latest. The module titles are:

GDPR Overview Data Breaches Data Handling (Best Practice)

Each one is only 15 minutes, and you can find them in the Cyber Security Collection if they are not already assigned to you when you log in.

 If you're worried that something has been accidentally shared when it should not have been - a data breach - <u>use the online form to report it here</u>. It doesn't matter if it turns out that you've been over cautious - much better that way!

A distressing article reported in the news regarding a teenager sentenced to six years in prison for being involved in a Satanist terror network.

It serves as a reminder to keep talking to children about them talking to an adult about their worries on online content and parents to monitor their child's internet usage.

On the home page you will be asked to enter your name and email address, create a password and choose who you work for from a dropdown menu (you should choose St Benet's) and this will then take you through to the welcome page. The Spectrum.Life service also includes access to 6 free counselling sessions (virtual or face-to-face) via the Employee Assistance Programme, access to a Discount Marketplace, advice on fitness, nutrition and many articles, videos and audios around wellbeing.
